4. MINUTES

The Parish Council **RESOLVED** to accept the Minutes of the Parish Council Meeting held on Monday 7th November 2022, having been copied to members was taken as read and confirmed and signed as being a correct record.

5. PROGRESS REPORT

- -The Clerk shared a response received with regards to an uncut hedge and mud on the pavement along Manchester Rd. The PC agreed that the Clerk should respond to ask if the PC can trim parts of the hedge which are covering road signs.
